

#### **History of the Centre**

The Plunkett Centre is Australian Catholic University's oldest research centre. It was established in 1989 at Catholic College of Education Sydney with the active support of several Catholic congregations, in particular the Sisters of Charity. In 1991, at the invitation of the Sisters of Charity, the Centre was moved to the campus of St Vincent's Hospital and in 1992 the Senate of Australian Catholic University entered into its first Memorandum of Understanding with St Vincent's Hospital. The Centre is named after John Hubert Plunkett, the first Catholic Solicitor General and Attorney General of the colony of New South Wales, a great Australian and a great friend and supporter of the Sisters.

#### **From the Director**

Our report for 2008 conveys something of our achievements in conducting and promoting research, providing research training and supervision, developing and teaching courses, conducting ethical reviews of professional practice, offering an ethics consultation service and participating in public discussions.

Highlights include the 'research into principles' found in the thesis for which Dr Garry Nieuwkamp was awarded a PhD, and the 'research into practice' exemplified by the study of patient preferences with respect to control over decision-making at the end of life.

Dr Nieuwkamp, Director of Emergency Medicine at Gosford Hospital, examined the recent revolution in clinical practice and the law with respect to informed consent. He argued that the way informed consent is obtained is imbued with uncertainty. The uncertainty, he claimed, is due partly to the conceptual opacity of important core concepts, partly to the complexity of communication in clinical encounters, and partly to the increased significance of respect for patient autonomy in the context of changes to the doctor-patient relationship. He examined the introduction of evidence-based medicine, together with the institutionalization of clinical governance and the application of quality improvement philosophy in health care. He argued that these 'movements' may well help to reduce some of the uncertainty which besets ethical standards with respect to obtaining the patient's informed consent.

Rohini Vasudevan, a third year medical student from the University of New South Wales, made a significant contribution to our study of patients' preferences with respect to control over decision-making at the end of life. The study showed that patients' preferences about control whether they wish to make decisions independently or to rely on help from their doctor and/or family - are much more complex than is generally assumed by those who encourage patients and residents of nursing homes to fill out those pieces of paper called 'living wills'.

Once again, I would like to acknowledge the hard work and good cheer of my colleagues and the valuable guidance provided by the Management Committee.
