Foreword from the University

As Acting Dean of the Faculty of Theology and Philosophy and thus as Chair of the Management Committee for the Plunkett Centre for Ethics, I would like to introduce the Annual Report of the Plunkett Centre for Ethics for 2014, and to acknowledge the work of its two Academic staff, Dr Bernadette Tobin and Dr Steve Matthews.

The Plunkett Centre is the oldest centre in the Faculty, and indeed in the University itself. Established in 1989, its purpose is to deepen and advance knowledge and understanding of ethical issues in health care – by research, by teaching, by consulting with practitioners and by making a contribution to public discussion of emerging issues.



The Faculty itself, and the wider University, has undergone significant change in that time. In 2012 a plan to establish a national centre for ethics was superseded by the establishment of an institute for advanced research in the Faculty of Theology and Philosophy, with moral philosophy and applied ethics constituting one of the research strands therein. In 2013 the other research centres in the Faculty were amalgamated into a Faculty-wide *Institute for Religion and Critical Inquiry*. Its programs comprise Biblical Studies and Early Christianity; Catholic Thought and Practice, including Inter-religious Dialogue; Moral Philosophy and Applied Ethics; Philosophy and Phenomenology of Religion; and Religion and Society.

Given that the Plunkett Centre for Ethics was established under a Memorandum of Understanding between Australian Catholic University and St Vincent's Health Australia (Sydney), it retains its identity and focus under the terms of the Memorandum and is not thus a part of the Institute. An important goal for the Institute and the moral philosophy and applied ethics program within it is, however, actively to promote strong collaborative and mutually supportive relationships with the Plunkett Centre for Ethics and also with the local diocesan-based Catholic ethics centres in Australia. In this context, I commend the work of the Plunkett Centre, and join with Bernadette and Steve in expressing my gratitude to Donna Sofinowski, the Centre's Administrative Assistant, who resigned at the end of the year. I know they are delighted to have welcomed Yvette Zuidema in her place.

From the Director

Australia is a secular, pluralist, liberal society. The Plunkett Centre participates in public deliberations about the ethics of health care as one among many groups and individuals similarly participating. We participate on the basis of the two key ideas: that the Catholic faith itself encompasses a body of propositions which are accessible to reason unaided by revelation, and that the role of a Catholic healthcare Centre is to identify the moral principles and norms which any public policy must meet if it is to be morally acceptable not only to Catholics but also to anyone of good will. We recognize that some of the propositions which inform our work are



controversial. We also recognize that there is room for legitimate debate about the meaning and implications of key ideas in the Catholic Christian tradition. So our aim is to clarify the fundamental principles which ought to inform our care for sick people, and to investigate their implications in particular circumstances, and to contribute our reflections to both the literature on this subject and to decision-making by individuals and institutions.

In the pages which follow, you will find the results of our efforts in that regard in the year 2014. We are a small Centre: two full time staff, two honorary staff, and an administrative assistant. You will, however, notice the outstanding contribution of my colleague Dr Steve Matthews. He continues to make a name for himself in an arena of research which might be called 'psychiatric ethics'. There, his particular contribution is to reveal how psychopathology can threaten our moral identity and thus our moral agency. This work continues a long tradition of thinking in the Catholic tradition about the ways in which our innate free will may be compromised by our background and our experience.

Late in the year we farewelled Professor Anne Hunt. In her capacity as Dean of the Faculty of Theology and Philosophy, Anne had been the Chair of our Management Committee. Chairing the meetings of the Committee by telephone from Melbourne, and involving key staff from the Faculty Office Melbourne to help us with financial matters and matters of information technology, she was a source of advice and support. We shall miss her.

And we shall also miss Donna Sofinowski, our Administrative Assistant for the last two years. Donna was often the public face of the Plunkett Centre. She handled enquiries over the phone in a most courteous and friendly manner, and took endless pains to ensure the smooth functioning of the Centre. She too will be missed.

Research

The Plunkett Centre conducts research in the following areas:

- **Contemporary normative theory,** in particular virtue theory, and its relation to Kant's ethics and consequentialism.
- **Clinical ethics,** in particular the goals of medicine, the canons of therapeutic responsiveness; competence, consent and decision-making about sick children; end-of-life decision-making; advance care planning; assisted reproductive technologies; organ and tissue donation; professional role ethics, the law and clinical ethics; regenerative medicine; public health ethics.
- **Psychiatric ethics,** in particular the threat of psychopathology to moral identity and moral agency, respect for autonomy, competence and coercion, moral responsibility of impaired persons, law and psychiatry, and the ethical challenges posed by developments in neuroscience.
- **Bioethics**, in particular the Catholic Christian contribution and its debates with and relationships to contemporary secular bioethics; the Metaphysics of the Incarnation; Human Sexuality and Procreation; the history of parental involvement at the end of life; words and ideas employed in end of life discussions; the meaning of suffering in the Intensive Care Unit; the history of organ donation; Issues around dead bodies.
- **Research Ethics**, in particular traditional debates about ethical standards with respect to research involving human participants and research involving animals; contemporary debates about genetic technologies, biotechnologies, stem cells, biobanking, etc.
- **Resource allocation,** in particular debates about the roles of the individual, the family, the market and the state in the provision of health care.
- **Computer ethics (in medical contexts)**, in particular the role online therapies play in treatment, reduction in costs, effectiveness and in threatening the clinician-patient relationship.
