

DIGEST - ACADEMIC BOARD MEETING 04/2025, 9 July 2025

A summary of the Academic Board meeting 04/2025 held on 9 July 2025 is detailed below.

Chair of Academic Board's Update

Academic Board:

- endorsed the Provost, Deputy Vice-Chancellor (Education) (DVCE) and Pro Vice-Chancellor (Indigenous) Risks Submissions.
- discussed and noted the new TEQSA Guidance Notes: Staffing; Learning Resources and Educational Support
- noted the Chair of Academic Board Approvals.

As part of the Action Items Update, the Academic Board reviewed the proposed options for the Progress Outcome Rate benchmark (Attachment B – Action AB 2025/007, Institutional performance against the Schedule A Benchmarks) and endorsed Option 2. This option retains the current benchmark while modifying the calculation method to include only students who subsequently enrol at ACU.

Vice-Chancellor and President's (VCP) Update

The VCP provided an update on several key matters:

- the post-election landscape in higher education, including recent meetings between the
 university and newly elected members of parliament representing electorates where ACU
 campuses are located.
- the establishment of the Australian Tertiary Education Commission (ATEC), outlining its mandate, anticipated impact on the sector, and initial priorities.
- Universities Australia's ongoing efforts to address antisemitism within the higher education sector.

Academic Board noted the Artificial Intelligence (AI) Council Progress Update on the Implementation of the AI Action Plan as provided by Professor Tania Broadley, Deputy Vice-Chancellor (Education) (DVCE).

Provost's Update

- the successful hosting of the Air Aware Hackathon 2025 at the North Sydney Campus on 7–8
 July.
