

There are many opportunities to broaden your legal skills at ACU – from mooting, advocacy, negotiation, dispute resolution and pro bono placements through to developing your communication skills. Put your legal skills into practice and make a real contribution to the community.

## MOOTING, NEGOTIATION, AND CLIENT INTERVIEWING COMPETITIONS

Our state-of-the-art mooting facilities are the perfect place to practice before competing in mooting and negotiation competitions, here and abroad.

The Thomas More Law School has a full range of activities designed to develop your skills as a legal problem solver and advocate.

Mooting competitions include First-Timers Moot, internal moots, intervarsity mooting, and international moots such as the Willem C Vis International Commercial Arbitration Moot. The Willem C Vis Moot is the world's most prestigious private international law mooting competition, with the competition's oral rounds being held in Hong Kong and Vienna each year. This moot aims to foster the study of international commercial law and arbitration for resolution of international business disputes.

## PRO BONO PLACEMENTS

Every undergraduate law student at the Thomas More Law School undertakes a pro bono placement as part of their degree.

Through these placements students have contributed many thousands of hours to the legal profession and to the community, representing the interests of those who might not otherwise have access to justice.
