CREATE and sustain a collegiate, supportive and highperformance research culture to attract world-class researchers and research students.







Welcome to the 2022 Annual Report for the Nursing Research Institute (NRI).

In 2022, the NRI research team consisted of 29 core staff located across New South Wales, Victoria and the Australian Capital Territory. The team worked on 28 projects, 20 of them with our partners, St Vincent's Health Network Sydney and St Vincent's Hospital Melbourne. In collaboration with national and international research partners, we received 10 new grants, totalling \$4,672,259, two of which are funded by the National Health and Medical Research Council (NHMRC). NRI researchers produced 29 publications in high-impact journals as either first or co-authors. In this report, we showcase the nurse and allied health-led research of NRI staff, students, clinician researchers and other achievements from 2022.

Of note, is the work in building allied health research capacity of Dr Lauren Christie, who is based at the NRI and jointly funded by the Australian Catholic University and St Vincent's Health Network Sydney as the Allied Health Senior Implementation Science Research Fellow. In 2022, allied health researchers received 4 new grants totalling \$79,090, worked on 6 projects, and were first or co-authors on 13 publications in high-impact journals.

Some highlights include:

DIRECTORS' REPORT CONTINUED

AWARDS AND RECOGNITION

Professor Sandy Middleton, Professor Elizabeth McInnes and Simeon Dale, with other QASC Research investigators, were finalists in the 2022 Engagement Australia Excellence Awards. The QASC research program has recently led to successful practice change for nurse-led stroke care in 64 hospitals in 17 European countries.

The **QASC Europe project** was recently showcased as part of St Vincent's Health Network Sydney's 'strength inventory'. This project was highlighted in a bid to the NSW Government's 'Health Precinct Strategy' to establish the St Vincent's Health Precinct Sydney.

Simeon Dale was awarded a 'Spirit of Excellence Award' from the Angels Initiative at the 2022 World Stroke Congress for her commitment in facilitating nurse-led stroke research.

John Forster, Psychiatric Consultation and Liaison Nurse, St Vincent's Hospital Melbourne (SVHM) and ACU Clinical Fellow, was awarded St Vincent's Hospital Melbourne, 2022 Nurse Researcher of the Year Award at the 2022 Nursing Excellence Awards.

GRANTS

Professor Sandy Middleton is a Chief Investigator on a \$2.5M NHMRC Centre of Research Excellence grant – Accelerate Stroke Trial Innovation and Translation. The CRE aims to transform interdisciplinary stroke clinical research in Australia and will use technology to deliver interventions.

Nicola Fearn, NRI Senior Research Officer Allied Health, was awarded a St Vincent's Curran Foundation Endowment Grant for her research: SUppoRting PAtient-centred SurvivorShip (SURPASS) at St Vincent's Health Network: Adaptation and adoption of the 'My Personal Plan' Prostate Cancer Survivorship Care Plan for generic use. The project was developed in collaboration with Professor Suzanne Chambers, Executive Dean of Health Sciences.

SCHOLARSHIPS

Alysia Coventry, NRI Senior Research Fellow, was awarded the inaugural 2022 Dame Quentin Bryce Palliative Care Nursing Research Fund scholarship, University of Melbourne, to support her PhD work on end of life care in intensive care.

Jake McMahon, NRI Clinical Research
Nurse, is a PhD student with the NHMRC
Centre of Research Excellence (CRE) in
wiser wound care and is also one of nine
clinicians participating in the inaugural
Melbourne Academic Centre for Health
Service Research (MacHSR) Future Leaders
Fellowship Program, the only nurse to be
selected into this fellowship. With his project
'Exploring the uptake of evidence-based
strategies to manage and prevent pressure
injuries in the acute setting', Jake aims to
understand and reduce low-value practices
associated with pressure injury prevention
and management for hospital patients.

PUBLICATIONS

A unique international collaboration between QASC Investigators, the European Stroke Organisation (ESO), the European Acute Networks Striving for Excellence in Stroke (Angels) Initiative and the global Registry of Stroke Care Quality (RESQ), resulted in successful rapid implementation and scale-up of FeSS Protocols into 64 hospitals in 17 countries with vastly different healthcare systems. Results were published in the *European Stroke Journal*. https://doi.org/10.1177/23969873221126027

Dr Kathleen Bagot, NRI Research Officer, and Adjunct Professor Kathryn Riddell, Chief Nursing Officer of St Vincent's Hospital Melbourne, published a study in the Journal of Advanced Nursing entitled 'The context, contribution and consequences of addressing the COVID-19 pandemic: A qualitative exploration of executive nurses' perspectives'. The study interviewed nursing executives and found that, despite challenges, the COVID pandemic facilitated championing of innovative work practices to support patient and staff safety. https://doi.org/10.1111/jan.15186

A pilot study led by **Dr Lauren Christie** and Dr Mitchell Sarkies (Macquarie University) in collaboration with St Vincent's Emergency Department showed a significant increase in injuries to commercial food delivery cyclists. Compared to recreational cyclists, commercial cyclists were over 13 times more likely to present to the emergency department. The findings from

the study were featured in *The Guardian* and on ABC National Breakfast radio. https://doi.org/10.1186/s40814-022-01077-1



Dr Ching Shan (Angela) Wan is an Accredited Practising Dietitian and Early Career Researcher appointed as Research Fellow funded by the National Health and Medical Research Council (NHMRC) Centre of Research Excellence (CRE) in Wiser Wound Care. She is also Adjunct Research Fellow at the Menzies Health Institute Queensland (Griffith University). Angela is an implementation science researcher and since 2014, has been involved in hospital evidence translation research projects focused on improving patient safety and reducing hospital readmissions.

Angela works with Professor Elizabeth McInnes as an investigator on the NHMRC CRE in Wiser Wound Care, led by Griffith University. Working with CRE researchers and St Vincent's Hospital partners in Sydney and Melbourne, Angela's research is focused on developing a clinician and consumer co-designed evidence-based intervention to improve the uptake of evidence-based guidelines for pressure injury prevention in hospitals.

Since commencing her role in 2021, Angela has obtained \$40k in Category 2–3 competitive grants. She is currently involved in updating a Cochrane review on *Nutritional interventions for preventing and treating pressure ulcers* (under review) and with CRE collaborators was an author on a systematic review and meta-analysis on the prognostic value of oedema measurement in predicting future pressure injury (published in the *International Journal of Nursing Studies* https://doi.org/10.1016/j.ijnurstu.2022.104189).

Simeon Dale is the NRI Clinical Research Fellow and Quality in Acute Stroke Care (QASC) Trials Manager. Simeon's background is in critical care nursing, spanning 20 years and three countries.

Simeon was Trial Manager for the QASC trial, a multisite, cluster randomised controlled trial that was published in 2011 in *The Lancet*. The trial showed that implementation of nursing protocols to manage fever, glucose and swallow (FeSS) difficulties following stroke significantly increased the chance of being alive and independent 90 days post hospital admission. Following this seminal trial, Simeon managed a pre-test/post-test study of NSW-wide implementation of the FeSS protocols in stroke units and then an NHMRC-funded trial, the T3 Trial, that aimed to implement the FeSS protocols into the emergency department.

Recently, Simeon has remotely managed from Australia the QASC Europe pre-test/post-test study that enrolled 64 hospitals in 17 countries. This study, a collaboration between the NRI, the European Stroke Organisation, the Angels Initiative and Registry of Stroke Care Quality (RES-Q), is the largest study undertaken within the QASC research program. It was highly successful, showing significantly improved FeSS protocol adherence:

In recognition of her expertise in the management of trials and large-scale evidence translation projects, in 2022 Simeon was awarded a Spirit of Excellence Award for commitment to excellence from the Angels Initiative at the World Stroke Congress in Singapore.

Nicola Fearn works at the Allied Health Research Unit at St Vincent's Hospital Sydney (SVHS) with Dr Lauren Christie, and is based at the NRI. She is an occupational therapist and accredited lymphoedema therapist who has worked in acute and community health services in Australia and the United Kingdom. In 2022, Nicola completed her PhD, which examined the incidence and risk factors for breast lymphoedema following early breast cancer treatment.

At the end of 2022, Nicola, along with a multidisciplinary team from the Kinghorn Cancer Centre and in partnership with the NHMRC Centre of Research Excellence in Prostate Cancer Survivorship, was awarded a St Vincent's Curran Foundation Endowment Grant for the SUppoRting PAtient-centred SurvivorShip at St Vincent's Health Network (SURPASS) Study. The study aims to implement a survivorship care plan for patients with cancer that is based on the 'Survivorship Essentials Framework' and 'My Personal Plan' developed by Professor Suzanne Chambers, Professor Jeff Dunn and the Prostate Cancer Foundation Australia.
