# 7.3 2020 Graduation Changes due to Pandemic

The Vice-Chancellor provided Senators with the rationale for proposed resolution to cancel graduation ceremonies for 2020 and offer students the option of formal campus-based photography sessions.

Senate approved Option 2 as contained in Attachment A of report, the cancellation of all graduations for the remainder of 2020 and that ACU offers students the option to attend campus-based photography sessions in regalia with their families, as detailed in Document 7.3.

# 7.4 Higher Education Funding Reforms

The Vice-Chancellor outlined the features of the Higher Education Funding Reforms: Job-ready Graduates Package from the Commonwealth Government which incorporates changes to rates of funding for Commonwealth Supported Places (CSPs), three-year guarantee of base funding levels (pending endorsement from the Treasurer) and a potential increase in institution funding based on the location of their campus(es) (regional and high growth metropolitan).

Senate discussed and affirmed its commitment to, and investment in, teaching and research in the arts (including the Arts Intensification Strategy) in the light of the proposed significant increase in student contributions required to study undergraduate humanities subjects as part of the reforms. Senate acknowledged the MOU with the Ramsay Centre for Western Civilisation and the new Bachelor of Arts in Western Civilisation.

The Vice-Chancellor provided the background for other proposed Commonwealth Government reforms, including:

- the Indigenous, Regional and Low-SES Attainment Fund (IRSLAF) which
  would have a value of \$500 million per annum nationally and would be
  funded through the combining of various equity and access funding
  measures (including the Higher Education Participation & Partnerships
  Program);
- greater discretion for higher education institutions to offer sub-bachelor and postgraduate courses instead of funding on the basis of designated relevant courses.

The Vice-Chancellor stated that Government's reforms would need to be legislated and may be introduced to Parliament in August enabling implementation from 2021.

#### 7.5 TEQSA

Senate noted that ACU's TEQSA registration which was due to expire on 30 July 2022 had been extended to July 2025. Senate noted that TEQSA's registration renewal status report for ACU had provided a list of action areas for improvement for July 2025. ACU's CRICOS (Commonwealth Register of Institutions and Courses for Overseas Students) registration had also been renewed for a period of seven years to 17 February 2027.
