Video Conferencing Tools

If you are using Zoom for teaching purposes, please refer to <u>these important security</u> <u>recommendations</u> that should be applied to all Zoom meetings.

The recommended video conferencing tool for staff is <u>Microsoft Teams</u>. Microsoft Teams should be used for all internal meetings. Skype for Business can still be used but staff will soon be migrated to Microsoft Teams so now is a great time to practice using Teams.
