Dr. Susan Darzins is a registered occupational therapist and academic. Susan has extensive experience as a tertiary level educator with leadership responsibilities, and as a researcher. She has been employed at Australian Catholic University since 2014, first as a research officer, then as a Level B Academic (Teaching and Research pathway), and since 2017 she has been a Level C Academic (Teaching and Research pathway) in the School of Allied Health. Susan was employed at La Trobe University as a Level B academic from 2000 to 2014. Her PhD was conferred in April 2016 and she was the first ACU Doctoral graduate in Occupational Therapy.

For the past 22 years as an academic, Susan has developed tertiary level curricula, led tertiary programs of study and coordinated and taught units of study at both undergraduate and post-graduate level. She has extensive expertise in use of enquiry-based learning methods to create flexible learning structures that enable students to be engaged as directors of their own learning.

In 2016, Susan was a co-investigator in a National randomised controlled trial funded by the Australian Government, attracting \$1.2 million, investigating student learning outcomes from simulated clinical placement when embedded in occupational therapy clinical training, as replacement for traditional clinical placement.

In 2021, Susan led development of the Australian Catholic University Interprofessional Education Framework, which has gained active support. She now leads a growing program of interprofessional education in the School of Allied Health with collaborators across the Faculty of Health Sciences.

Susan is actively engaged in embedding First Peoples' curricula into the Bachelor of Occupational Therapy at ACU and is committed to developing graduates who advocate for equitable health services and health outcomes for First Peoples and who practice in culturally safe and responsive ways. In 2020 Susan was awarded a Vice-Chancellor's Staff Excellence Award in the category "Spirit of Reconciliation" as a member of the team advancing this work.

Susan's professional research focuses on the measurement of participation-related concepts, as described by the World health Organisation; evaluation of health services aiming to support people to live in the community; and building evidence about occupational therapy practice. Susan has local health sector, national, and international research collaborators and has disseminated her research globally. Susan has extensive experience as a supervisor of student research projects, having supervised 16 Honours projects and 5 Higher degree student research projects to completion and she is also supervising a Doctoral research student.

Susan's clinical expertise has focused on assessment of work capacity and return-to-work for adults who experience disruption to their worker roles. She was the director of the Vocational Assessment Unit at McMaster University and worked in this field for several years in both public and private practice settings in Australia and Canada.
