### **Chair of Academic Board's Update**

#### Academic Board:

- endorsed the Chair of Academic Board and Student Administration Risks Submissions.
- noted the Chair of Academic Board Approvals.

## Vice-Chancellor and President's (VCP) Update

# The VCP reported on:

- the recently held Annual General Meeting (AGM) of the Corporation advising that members received and noted the 2024 Annual Report.
- the changes to the government following the recent federal election and potential impacts for the sector.

# **Provost's Update**

# The Provost reported on:

- the announcement that Professor Mary Ryan, Executive Dean, Faculty of Education and Arts (FEA) was departing ACU. She thanked Professor Ryan for the great work accomplished by FEA under her leadership.
- student load numbers, advising that they were strong. Professor Cogin provided an overview of the work of the Admissions and Marketing teams to convert applications into enrolments and advised that she was confident that ACU would reach its target.
- the decrease in International student load numbers due to several reasons including changes to policy.
- the double degree in Computer and Data Science advising that Associate Professor Eila Erfani had recently commenced at ACU as part of the leadership team for the degree.
- sponsorship of several programs by industry partners including Microsoft.

Academic Board discussed and noted the Report of the Provost including the 2025 enrolment outlook, Faculty health checks, Higher Degree Research snapshot and Faculty highlights.

#### Academic Board endorsed:
