- For reporting purposes, please indicate whether the organisation is Catholic or faith-based.
- If yes, please provide brief details
- Does the organisation have an existing relationship with ACU? If yes, please provide brief details
- For reporting purposes, please indicate if you have consulted with any ACU staff about your EOI? If yes, please provide the staff members' name/s

### 3. ABOUT THE RESEARCH PROJECT

Tell us about the research project:

If yes, please tell us how your organisations are connected, how long they have been working together, and which shared goals they have for the project. We recognise that different organisations might play different roles in the project based on their connection to the research topic, and if that's the case, please let us know how you see each organisation engaging with the research.
