1. Report from Chancellor

The Chancellor provided an introduction and a summary of the events and meetings in which he had participated since commencement, including:

2. Report from Vice-Chancellor and President

The Vice-Chancellor and President (VC) provided an overview of the Report from the Vice-Chancellor and highlighted the following:

- The Young University Rankings 2022 has placed ACU number 39 in the world, up three places from 42 last year;
- An Innovation Memorandum of Understanding (MoU) with the NSW Government was signed. ACU
 was one of several NSW universities to sign the MOU, which seeks to improve collaboration
 between the government and the university sector on projects that will deliver social and economic
 benefits to the people of NSW;
- Prof Belinda Tynan, former Provost departed ACU in Jan 2022;
- Prof Meg Stuart has been appointed as Interim Provost;
- Attended Book of Prayer launch;
- Attended Mass of Installation of ACU Chancellor;
- Prof Mary Ryan has commenced as Executive Dean, Faculty of Education and Arts;
- Prof. Andrew Condon has been appointed to the new role of Industry Professor, Veterans and Their Families;
- Resumption of campus activities and face to face teaching is underway;
- Plans of a Rome Campus visit in March and campus activation; and
- An update was provided in relation to 2022 VC Priorities and the Strategic Plan. The Plan expires in 2024. Internal discussions have commenced and it will come to Senate later in the year.
