The Vice-Chancellor and President (VC) provided an overview of the Report and highlighted the following:

- Outcomes of the May federal election, noting the change of office holders in two ACU electorates: North Sydney and Reid (Strathfield campus):
- The recent consolidation of the School of Arts and the Institute of Humanities and Social Sciences into the School of Arts and Humanities;
- Gerontology expert Professor Laurie Buys has commenced as Professor of Healthy Ageing;
- Professor Tim McKenry, the Chair of Academic Board, will take on the role of Institutional Lead, Renewal of Registration, in addition to his existing duties, to oversee the University's TEQSA readiness:
- Establishment of a Leadership Centre in Townsville with a focus on providing information and advice to Veterans planning to disengage from service. It was noted an announcement would be made a few weeks post the Senate Meeting;
- Australian Veteran Services Mapping Project funded by the Royal Commission into Defence and Veteran Suicide as well as ACU's Student Veteran Employability Program funded by the 2022 Veteran and Community Grants Program;

- An extensive review of enrolment planning and associated admissions processes has been initiated;
- ACU Online enrolments have met load and exceeded targets in some courses;
- Six ACU Online courses have CSP attached. Commonwealth Supported Places were approved midway through recruitment, and enrolment subsequently increased;
- New courses and opportunities are being pursued and built into the 2023 and 2024 ACU Online
  offerings. Faculties are preparing business plans and targets validated against marketing insights,
  with a number of courses being considered; and
- ACU is piloting the Common Purpose Global Leader Experience (CPGLE) for emerging leaders. 72 students will come together to come up with a proposal for the question "How do we advance healthy ageing in our communities by strengthening inclusion and access?".
