

#### SENATE DIGEST FOR MEETING OF 2 NOVEMBER 2023

#### 1. Welcome and Apologies

The Chancellor welcomed Senators and attendees to the meeting and apologies were noted.

#### 2. Report from Chancellor

The Chancellor observed that the written Report contains a summary of the events and meetings in which he had participated since the previous meeting and discussed the Universities Accord Interim Report.

### 3. Report from Vice-Chancellor and President

- ACU has secured almost \$11.5 million in new research funding in 2023;
- A number of events across ACU including Blessings of the Saint Teresa of Kolkata Building;
- The unique relationship in Townsville with the Australian Defence Force is set to grow with additional defence force personnel. It is setup for current and ex-serving members and their families to study at ACU with additional support; and
- Hungarian President Katalin Novák visited ACU's North Sydney campus as a guest of PM Glynn Institute.
